### **Inflatable Bouncer Rules**

- Remove all sharp or pointed objects before entering
- Remove shoes, jewellery, glasses, cell phones - socks are required
- No food, gum, drinks, or sprays inside
- Maximum bouncers at one time- 6
- No tumbling, flipping, wrestling, chasing or piling onto others
- No rough play
- Do not enter if you are pregnant
- Do not play near the entrance or exit
- Do not jump against, climb, or play near the sides or walls
- If the unit begins to deflate remain calm and carefully exit the unit
- Only one rider sliding at a time
- Staff on duty will assist with any situation that might occur
